Further, it is the primary duty of the registered proprietor to watch all Trademarks Journals (Government Gazette) so as to ascertain whether your Trademark registered under the same class and goods has been applied for registration by the third party, and if so, we have to oppose the same. Kindly note that it is the practice of the Trademark Registry to register the Trademark, which is unopposed. If you find any party duplicating your registered Trademark please don't allow them as it may affect your registered Trademark. Please feel free to inform us for any action required to be taken in case of such incidents.

By getting this registration you can take criminal as well as civil action for passing off Trademark, infringement of Trademark duplication of Trademark against a person according to provisions of The Trademarks act, 1999, Indian Penal Code and common law.

Please also note that the original certificate issued by the department cannot be issued again and therefore we are forwarding the registration certificate with lamination so that the life of certificate can be at least 100 years. We at our end have taken utmost care by laminating the certificate however it is your duty also to keep the certificate safely.

We once again sincerely advise your good self to safeguard your registered Trademark and make regular fees for renewal of Trademark every 10 years (As per the present Trademarks Act, 1999).
